ABOUT THE COLLEGE

Jagarlamudi Chandramouli College of Law is named after Sri Jagarlamudi Chandramouli, Advocate, former Member of Rajya Sabha, former Member of AP State Legislative Assembly, Educationalist and Philanthropist. The College is sponsored by Nagarjuna Education Society, Guntur (Regd. No. 56 of 1967) and was inaugurated on 22-06-1991 by Hon'ble Justice (Retd.) S. Parvatha Rao the then Judge of High Court of A.P. and is affiliated to the Acharya Nagarjuna University (ANU), having permission of Andhra Pradesh State Government and approval of affiliation of Bar Council of India (BCI). At present the College offers 3 Year LLB course with an intake of 180 students, 5 Year BA LLB course with an intake of 60 students. LLM course with two specializations will be started soon.

The programmes offered at college incorporate many activities like debate, moot court etc. Jagarlamudi Chandramouli College of Law constantly endeavours to provide the best possible facilities towards attaining its desired objectives of providing quality education and selflessly strives for the betterment of the students.

ABOUT THE MOOT

The College gives top priority to classroom teaching. Apart from this the College constitutes various cells/committees that are run by the students, like, the Moot Court Committee, Sports and Cultural Committee, JCCL Career guidance cell, Legal Aid Cell, Medical camps by JCCL OSA etc. College has an Alumni Association, which consists of the practicing advocates, judicial officers, judges, professionals, and so on. To enhance teaching learning practices, periodic special lectures and seminars by eminent jurists and legal practitioners are organized by the institution.

After successfully conducting the 1st Moot Court Competition in the month of February, 2020, 2nd Moot Court Competition in the month of February, 2023 and 3rd Moot Court Competition in the month of February, 2024 the Managementthis year is very happy to add up one more to the list – The 4th Moot Court Competition on 1st and 2nd of February, 2025.

Moot Court is going to be developed into a key extracurricular activity in Jagarlamudi Chandramouli College of Law, as the College feels that mooting helps the law students the best. The College deems it as a right path to reach out to the future needs of legal aspirants and to recognize their talent and help them improve their skills of drafting and mooting. Therefore, here stands the J.C. College of Law conducting, its Fourth Moot Court Competition.

Moot Case

Aadhvitha D/o Rama Rao, aged about 23 years and Aayan S/o Khan, aged about 23 years are classmates studying final year of LL.B. in J C College of Law, Guntur and friends and want to marry. They are the residents of Guntur City, Andhra Pradesh. The two have decided about their future life. According to the consensus between the two – Aadhvitha shall continue to follow her Hindu religion and Aayan shall continue to follow his Islam religion. Further, they have agreed that nobody would interfere with religious feelings of the other. Aadhvitha has asserted that she had no intention to convert to Islam. Aadhvitha and Aayan gave Notice to the Marriage Officer, Guntur under Section 5 of Special Marriage Act, 1954 for registration of their marriage. Aadhvitha's father raised the following objections to the marriage that – Aadhvitha has left the house by taking away jewellery of all the family members, that she has taken away cash and that if she goes for an inter-religion marriage his family would be boycotted by the society. As a result, the Marriage Officer has not given date for registration of marriage. Aadhvitha fears that her father would file criminal case for abduction against Aayan. Out of fear of physical attacks Aadhvitha and Aayan could not meet the Marriage Officer in his office.

Aadhvitha and Aayan filed a Writ Petition under Article 226 of Constitution of India before the Hon'ble High Court of Andhra Pradesh seeking a) a direction to the Marriage Officer to give a date for registration of marriage of the Petitioners b) a direction to the State Government to provide security to the Petitioners from the family members of Petitioner No.1 Aadhvitha c) to provide the follow-up guard to the Petitioners for appearing before the Marriage Registration Officer and d) for a direction to the State Government not to register any criminal case against Petitioner No.2 for abduction or any other offence filed by the father of Petitioner No.1.

The High Court directed the Counsel for the Petitioners to address the Court as to whether marriage of Petitioner No.1 with Petitioner No.2 will be a valid marriage.

The Court heard both the Counsels and held that "as per Mahomedan Law, the marriage of a Muslim boy with a girl who is an idolater or a fire -worshipper is not a valid marriage. Even if the marriage is registered under the Special Marriage Act, 1954 the marriage would no more be a valid marriage and it would be an irregular (*fasid*) marriage, as the parties are within the prohibited relationship". The Court was of considered opinion that "no case is made out warranting interference".

Aggrieved by the decision of the High Court the Petitioners preferred Appeal by Special Leave to the Supreme Court of India. The Appellant No.1, Aadhvitha filed an Application stating that "assured of the Right to Freedom from Religion inherent under Article 25 of the Constitution of India Appellant No.1 wants to live non-Religious". The Respondents contested the Application and Appeal. The matter is postedfor final hearing.

Disclaimer: The names of the Hon'ble Courts are used merely for the sake of avoiding coining of fictious names and for the convenience of the participants.

RULES GOVERNING THE COMPETITION

General

- 1. The Competition shall be held for two days on 1st and 2nd February, 2025 (Saturday and Sunday).
- 2. The Competition shall be open to *bona fide* students pursuing 3 Year LL.B. Course or integrated 5 Year LL.B. Course offered by a Law School/Affiliated Law College/University Department or College/Centre of Legal Education recognized by Bar Council of India.
- 3. The language of the Competition shall be English.
- 4. Only 32 teams shall be registered for the Competition on 'first come first serve' basis. The Organizing College shall reserve the right of registration. It may invite to the competition a School/College/Department/Centre that is not registered. To face the problem of last minute dropouts the college may register another four teams.
- 5. Each participating team shall consist of three members i.e. Two Mooters and One Researcher. Due to an exigency the Organizing College may allow a two-member team to participate in the Competition, when registered with three members.
- 6. One team only is permitted to participate from a School/College/Department/Centre.
- 7. The participating teams shall bear the travelling and all other incidental expenses.
- 8. The Organizing College shall provide free lodge and boarding to the participating teams. Depending upon the travel plan of the participating team accommodation shall be provided from afternoon of 31st January to afternoon of 3rd February, 2025. No accommodation shall be provided to the teams from nearby places. Accommodation is provided to participating team members only. Members are expected to use the accommodation in a decent and reasonable manner.
- 9. The dress to the participants shall be the dress prescribed to Advocates under Advocates Act.

10. The team of the Organizing College shall participate in the Competition.

- 11. The members of the participating teams shall maintain, during the Competition, decency and decorum of the Court and conduct themselves in the manner befitting of the legal profession.
- 12. The Organizing College shall have an inherent power to make Rules on any situation not covered in the Rules.
- 13. The decision of the Principal of the Organizing College shall be final with regard to the interpretation of the Rules and on any other matter or matters relating to the Competition not specifically provided for in the Rules.

Memorials

- a. Each team shall submit Memorials for both Petitioner and Respondent.
- b. The **text** of the Memorial shall not exceed 25 pages. The Memorials shall be typed on A4 size paper with standard margins on both sides in Times New Roman with font size 12 with double line spacing.
- c. Each team shall submit 06 copies of Memorials for each side. The separate copies that are to be submitted to the Judges shall be brought by the respective teams by themselves. The name of the institution or the names of the student participants shall not appear at any place in the Memorial. The Team Code allotted shall be typed at the top right corner of the cover page of the Memorial. The last date for submission of hard copies is 11th January 2025 to the postal address given.
- d. The cover page of the Memorial for the Petitioner shall be in blue colour and for the Respondent in red colour. Prefer chart paper or white paper to plastic sheet for cover page. Also prefer staples or cotton thread stitches to spiral binding.
- e. Soft copy of Memorials (in MS Word doc. & PDF format) shall be emailed to jcclmootgnt25@gmail.com latest by 3rd January, 2025 (23.59hours IST) with subject:

Conduction of the Competition

- 1. The competition shall be conducted in four rounds Preliminary, Quarter, Semi and Final rounds.
- 2. In the Preliminary rounds each team shall argue for both sides. Eight teams that achieve the highest marks in the Preliminary rounds shall become eligible to enter into the Quarter finals. In case of a tie, marks awarded to Memorials shall be considered. If the tie persists toss may be used.
- 3. Quarter, Semi and Final rounds shall be held on a Knock-Out basis.
- 4. In the preliminary rounds each team shall get 30 minutes time. The two Mooters can adjust the time between them. But, no Mooter shall argue for more than 20 minutes.
- 5. In Quarter and Semi Final rounds also each team shall get 30 minutes time. In all these rounds each team shall get 2 minutes time for rebuttals.
- 6. In the Final round each team shall get 40 minutes time and 5 minutes for rebuttals.
- 7. Memorials are valued separately. Memorials for each side shall carry 100 marks. Each Memorial is valued for 50 marks.
