## SUBMISSION GUIDELINES

## A. GENERAL REQUIREMENTS

#### || SUBMISSION PROCESS ||

- Submissions must be made in .doc or .docx format only with the file name as the title of the essay. No retractions shall be permitted in any case.
- No identifying information about the author(s) should be included in the manuscripts. Failure to comply with this rule will result in immediate disqualification.
- All submissions must be completed via a <u>Google form</u> before 11:59 PM of Last date of Submission.

#### | MANUSCRIPT GUIDELINES |

- Manuscript should be typewritten in British English on A4 sized paper in MS Word and should range between 3,000 to 6,500 words in length, excluding the footnotes and abstract.
- An abstract of 200-250 words is required and should be placed at the top of the manuscript, providing a clear summary of its structure and essence.
- The manuscripts must strictly adhere to the provided formatting guidelines.

#### || QUALITY AND ORIGINALITY ||

- Submissions should deal with relevant and contemporary legal and policy issues under the broad themes provided herein. It should strictly focus on the legal analysis of the covered topics.
- Manuscripts must be error-free, with proper attention to grammar, spelling, and punctuation.
- Only original content will be accepted.
  The use of AI tools is strictly
  prohibited, and such submissions will
  be outrightly rejected.
- Manuscripts that have already been submitted or published elsewhere must not be submitted.
- Paraphrasing or directly using content without proper citation of sources will be considered plagiarism. Any instance of Plagiarism found in the abstract or conclusion will result in immediate rejection. Plagiarism in the manuscript must not exceed 7%.


- Title [Times New Roman, 14 points, 1.5 line spacing, Bold, All Caps, Centre Aligned].
- Abstract [Times New Roman, 12 points, 1.15 line spacing, Italics, Justified, 3 cm indent on both sides].
- Heading Level 1 [Times New Roman, 14 points, 1.5 line spacing, Bold, Capitalize each word and Small Caps, Centre Aligned]. Numbering should be: I, II, III,
- Heading Level 2 [Times New Roman, 12 points, 1.5 line spacing, Italics, Sentence case, Centre Aligned]. Numbering should be: A, B, C, ...
- Heading Level 3 [Times New Roman, 12 points, 1.5 line spacing, Italics and Underlined, Sentence case, Left Aligned] Numbering should be: a), b), c), ...
- Heading Level 4 [Times New Roman, 12 points, 1.5 line spacing, Italics, Sentence case, Left Aligned]. Numbering should be: i, ii, iii, ...
- Main Body [Times New Roman, 12 points, 1.15 line spacing, Justified, 1-inch margins on all sides].
- Footnotes [Times New Roman, 10 points, 1.0 line spacing, Justified].

#### || REFERENCING REQUIREMENTS ||

- References should be only in the form of footnotes and must adhere to the 20th edition of the Bluebook citation style.
- References should be included as hyperlinks within the text if footnoting is not available.

## **EVALUATION PROCESS**

All submissions will undergo a three-stage review process, consisting of:



- Manuscripts not in conformity with given guidelines may be rejected at the sole discretion of the Editorial Board of the Gender Justice Cell.
- The Editorial Board reserves the right to edit and change your manuscript content for the original edition and or any subsequent revision along with the right to republish the article as part of an anthology in later years.
- It is the responsibility of the author(s) to ensure that the manuscript does not infringe copyright and due credits are given to all the contributors.
- The copyright of the manuscript finally presented shall vest jointly with the author(s) and NLIU. Where the author subsequently wishes to publish the article, the author is requested to obtain prior permission from the Editorial Board of GJC and acknowledge its prior submission to our Board.
- The Editorial Board may, at its absolute discretion, waive any of the above rules or amend the process. In the event of any dispute or ambiguity, the decision of the Editorial Board shall be final and binding.
