The above themes and sub-themes are merely indicative in nature and not exhaustive. Participants may submit an abstract on any contemporary, relevant, and connected issue on the intersection of criminal justice administration with technology.

DATES AND FURTHER DETAILS

The Conference is scheduled to be held on "8th and 9th of February, 2025". The Conference will feature plenary sessions, panel discussions, paper presentations, and interactive sessions among the participants, judges, speakers and attendees.

WHO CAN ATTEND

This Conference is aimed at students, researchers, academicians and practitioners in the areas of Criminology, Victimology, Law, Sociology, Information Technology, and allied sciences, Criminal Justice Professionals, NGO practitioners, and experts in the fields of cyber-crimes, information security and digital forensics. The Conference will have a balance of lectures and presentations from an academic as well as the practical perspective. It is aimed at creating a platform for a healthy exchange, discussion and development of ideas and emerging issues in the area of Law and Technology and its role in the Criminal Justice System.

CALL FOR SUBMISSIONS

Research Papers on the above theme and sub-themes are invited from faculties, researchers and students in the fields of Criminology, Victimology, Law, Sociology, Information Technology, and allied sciences, from Criminal Justice Professionals, NGO practitioners, and from experts in the fields of cyber-crimes, information security and digital forensics.

An abstract of the papers to be presented with not more than 250 words should be submitted on or before <u>3rd December 2024</u>, <u>11:59 P.M.</u> After the acceptance of the abstract, the full paper should be submitted on or before <u>31st January 2025</u>, <u>11:59 P.M.</u> The abstract and the full papers should be sent via a Google Form.

GCRCJS BEST PAPER AWARD

The GCRCJS Best Paper Award will be given for the top three research papers of the Conference across all the sessions.

CERTIFICATE

All the participants who will be presenting a paper will receive a Certificate of Paper Presentation whereas the winners of the GCRCJS Student Best Paper Award will be awarded a Certificate of Merit. Observers will also be given Certificate of Participation.

PAPER SUBMISSION GUIDELINES

Authors must adhere to the following guidelines for research paper

ABSTRACT GUIDELINES:

- The participants are requested to submit an abstract of a maximum of 250 words in Microsoft Word document:
- Font style (Italic) Times New Roman;
- Font Size 12;
- line spacing 1.5;
- The abstract may include keywords (maximum: five);
- The abstract must include a clear indication of the objectives, major results and implications;
- All abstracts will be subject to blind review and only those abstracts approved by the reviewers will be selected to submit their complete paper for the final presentation;
- The criteria for evaluation are Relevance, Methodology and Originality.

PAPER GUIDELINES:

- Name of the Author(s) or any other form of identification must not be mentioned in the Research Paper;
- Co-authorship is limited to a maximum of two (2) authors. Both the author and co-author have to be present to present the paper in order to be eligible for the Certificates;
- Word limit: 3000 4000 words, excluding Footnotes, Index, and Bibliography;
- Font style Times New Roman;
- Font size 14 for Headings (Heading 1 Bold and Alphabetical, Heading 2 Italics and Roman, Heading 3 Underlined and small alphabets), 12 for Body, 10 for Footnotes;
- Line Spacing 1.5 for Body, 1.0 for Footnotes;
- Citation Style OSCOLA;
- Margins 1 inch (i.e., 2.54 cm) on each side;
- Note: Speaking footnotes are allowed in the submissions but should be limited to 50 words;
- Plagiarism limit is 10% in accordance with UGC Guidelines;
- Use of Artificial Intelligence for submissions is strictly prohibited and highly discouraged;
- The abstracts that are selected for the final paper presentation will be provided the final paper submission link via email;
- Bibliography is mandatory at the end of the paper;
- Separate cover page to be submitted along with the final research paper which shall have details of the author(s), title of the page and code.

STEPS TO SUBMIT:

• The abstracts are to be submitted through the Google Form.

ABSTRACT SUBMISSION LINK

- Various information such as Name of Author(s), Email ID(s), Institute of Affiliation, Year of Study Theme of Paper and Title of the Paper will have to be submitted along with a word (.doc or .docx) format of the abstract with 3 to 5 keywords and separate cover is to be attached with the format given.
- A separate cover page containing this information has to be attached with the paper as well, in the given format as above.
- Upon acceptance of the submitted abstracts, the shortlisted candidates will be sent a link to another Google Form via email wherein the complete paper will have to be submitted in word (.doc or .docx) format.
- A team code will be allotted to the teams through the acceptance mail.

NOTE: Please ensure that only one author in case of co-authors, fills the form. Multiple Forms will not be accepted.

HOW TO REACH GNLU


