ABOUT THE CONFERENCE

The international dimensions of the climate change debate have reached an unparalleled level because of various peculiar and complex issues associated with it. India has an impressive record of grassroots environmental movements and deep historical traditions of environmental care. But despite this, our environment has been degrading day by day

to a level which can't be restored. Everyone wants to protect and improve its quality. But we miserably failed to translate these sentiments into a determinate plan for environmental action, which is the real need of the hour. Hence the gap between high rhetoric and implementation remains significant.

Environmental constitutionalism is a concept that is concerned with the constitutional protection of the environment. It is an extensive concept encompassing rights as well as duties of the State and individuals. Several national Constitutions incorporate environmental rights, environmental duties of the State, and environmental duties of individuals. The concept of environmental constitutionalism refer to a symbiotic relationship between environmental rights, on the one hand, and environmental duties of the State and individuals on the other.

The conference also seeks to serve as a platform to explore innovative solutions, policies, and practices by which environment can be protected and improved. These discussions will be relevant at all levels, i.e., the global, national and local levels, emphasizing the need for a comprehensive and inclusive approach to the broader goal of achieving the mandate of sustainable development.

CALL FOR PAPERS

We invite original research papers from academicians, professionals, practitioners, researchers, students of law, social sciences, and other stakeholders.

SUBMISSION GUIDELINES

For abstract

The abstract should not exceed 300 words (inclusive of 5 keywords) and must be accompanied by a brief bio-note (in 60 words) of the author indicating his/her email ID, contact number, designation, and official address.

The abstract should be in the following format:

- ⦿ Times New Roman, Font Size 12 & Line spacing 1.5, Justified.
- ⦿ 1-inch margins on all the four sides.
- ⦿ Submissions are to be made in MS Word format only.

The abstract must identify a research problem clearly to be discussed by the author in the full paper, and the particular theme of the conference associated with the paper.

File name of abstract should be as follows:

Full Name_title of the abstract, e.g., if author's name is Manish Kulkarni then the file name should be Manish Kulkarni_title of the abstract. The abstracts can be submitted through following link/QR:

Registration and Full paper submission

Selected candidates shall be intimated separately along with a link for full paper submissions and link for the payment of the registration fee.

The word limit for a full research paper along with an abstract is 3000-6000 words (excluding footnotes), which must be submitted in MS Word format.

Font: Times New Roman, Font Size: 12, Line spacing: 1.5, A4 size paper with 1” margin on all sides. For citation, the author is required to follow the Bluebook mode of citation/ILI citation. The final paper should mandatorily have the conclusion and suggestions made by the author(s). The language of submissions should preferably be English.

For Publication of Papers

- ⦿ Selected research papers may be published in an edited book by a reputed publisher having an ISBN.
- ⦿ The submitted papers shall be checked by the organising committee through a similarity software and it should not be more than 10%.
- ⦿ Selection for paper presentation in the conference does not entitle the presenters for publication of paper in the edited book.
