APPOINTMENT OF JUDGES FROM THE SC/ST AND FEMALE CATEGORY

Will the Minister of LAW AND JUSTICE be pleased to state:

- (a) the percentage of Judges from the SC/ST category out of total appointed Judges in courts operating in the country, State-wise;
- (b) the appropriate steps being taken by Government towards the appointment of women Judges and Judges from the SC/ST category in the High Courts of the country;
- (c) the current status of the number of vacant posts of Judges in the High Courts across the country, State-wise; and
- (d) the details regarding the number of Judges appointed per lakh people as per the Judge to population ratio in the country?

ANSWER

(a) & (b): The state-wise details of the working strength of Judicial Officers from the SC/ST category in District and Subordinate Courts is at *Annexure-I*.

Appointment of Judges to the Supreme Court and High Courts is made under Articles 124, 217 and 224 of the Constitution of India, which do not provide for reservation for any caste or class of persons. Therefore, category-wise data pertaining to representation of SCs, STs and OBCs among the Judges of High Courts are not centrally maintained. However, since 2018, the recommendees for the post of High Court Judges

are required to provide details regarding their social background in the prescribed format (prepared in consultation with the Supreme Court). As per the information provided by the recommendees, out of 698 High Court Judges appointed since 2018, 108 are women judges while 22 belong to SC, 15 belong to ST, 87 belong to the OBC category and 37 come from the Minority Communities.

As per the Memorandum of Procedure (MoP), the responsibility for initiation of proposals for appointment of Judges in the Supreme Court vests with the Chief Justice of India, while the responsibility for initiation of proposals for appointment of Judges in the High Courts vests with the Chief Justice of the concerned High Court, in consultation with two senior-most puisne Judges of the High Court. However, the Government has been requesting the Chief Justices of High Courts that while sending proposals for appointment of Judges, due consideration be given to suitable candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Minorities and Women to ensure social diversity in the appointment of Judges in High Courts. Only those persons who are recommended by the Supreme Court Collegium, are appointed as Judges of the Supreme Court and High Courts.

- (c): The current status of the number of vacant posts of Judges in the High Courts across the country, State-wise is at *Annexure-II*.
- (d): Based on the population as per Census 2011 which was 1210.19 million and as per available information regarding sanctioned strength of Judges in Supreme Court, High Courts and District & Subordinate Courts as on 31.12.2024, the judge population ratio in the country works out to be approximately 21 Judges per million population.
