# **CLIENT COUNSELLING**

### ABOUT THE EVENT

Client Counselling is a strategic skill which is deeply embedded in the basic principles of sound advocacy. The Client Counselling Competition promotes greater knowledge and interest among law students and exposes them to practical aspects of advocacy which help them to develop holistically. It also encourages students to develop interviewing, planning, and analytical skills in the lawyer-client relationship in the law office. Moreover, a healthy educational and cultural interchange between various learners, law teachers and legal practitioners is also envisaged.

### ELIGIBILITY

- The competition is open to all students currently pursuing bachelor's degree in law i.e. 3 Year LL.B. or 5 Year LL.B. Programme, or any post-graduate degree/diploma in law, from any recognized college/institute/university in India.
- 2 Each participant is required to carry his/her college ID-card on all days of the competition.

### TEAM COMPOSITION

- 1 One team shall comprise two participants only (Counsel 1 and Counsel 2).
- 2 Teams cannot be changed or altered after registration. Any change or alteration in the registered team is subject to the sole discretion of the Organizing Committee.
- 3 Team Codes shall be allotted to the respective teams upon arrival at the venue, by the Organizing Committee which shall be used to identify the team throughout the competition.

### **COMPETETION GUIDELINES**

### I. LANGUAGE

The Official language of the competition is English.

### II. DRESS CODE

For all rounds: Formals or Advocate's uniform as per the Advocates Act, 1961 (except band and gown).

### **III. STRUCTURE OF ROUNDS:**

- 1 A total of two rounds will be conducted as part of the competition. There will be a Preliminary round & Final round. Semifinal round may or may not be conducted and the same is subject to the discretion of the organizers.
- 2 In case of a tie, the team that has higher score for 'consultation' part, will advance to the next round.

### IV. COUNSELLING SESSION FORMAT:

Each session shall be divided into three parts, namely:

- a. Consultation
- b. Post-Consultation
- c. Critique Process:

### Consultation:

- 1 This time period shall start from the moment the client enters the chamber.
- 2 This time period is meant to be used for consultation with the client during which participants are expected to elicit the relevant information, outline of the problem, find the client's expectations etc.

### Post Consultation:

- 1 During this time period the client will leave the chamber and the team members may talk to each other in a manner that is audible to the judges.
- 2 This time shall start as soon as the client leaves the chamber.
- 3 The team members may talk with each other about the law which may concern the situation, clarification of facts; attorney fees etc. and the teams will be marked on the same.

### Critique:

- 1 During this time period the client will re-enter the chamber.
- 2 In this time period, the teams have to explain to the client the strategy for dealing with client's legal problem, the basis for their arguments and also clarify any doubts the client may have.
- 3 Some crucial information may be revealed by the client to the teams, but the participants will have to work for/around it...!
- 4 The judge(s) may ask questions during this time period.

### V. TIME DURATION:

The competition is structured into Preliminary and Final round each with specific time allocations for different stages of the counselling session. In the Preliminary round, participants will have a total of 15 minutes to complete their session. This time is divided into three stages: 6 minutes for the Consultation, 5 minutes for Post Consultation, and 4 minutes for Critique. The Final round and allows for more indepth interaction, with a total of 20 minutes allocated. During the Finals, contestants will have 8 minutes for Consultation, 6 minutes for Post Consultation, and 6 minutes for Critique. These carefully timed segments ensure a comprehensive evaluation of participants' counselling skills while maintaining a fair and structured competition format.

### VI. THEMES

The rounds will cover a broad spectrum of laws, including Constitutional Law, AI, Family Law, Cyber Law, Contract Law, Company Law, and Property Law, along with other relevant codified and uncodified laws. Participants must provide legal advice based on Indian law.

### VII. CLIENTS

- 1 The clients will be assigned by the organizers. Each team shall interact with their client for the first time during the 'consultation' session.
- 2 The participants shall be expected to interact with clients on the spot and no prior information with respect to the problem shall be intimated.
- 3 Participants' conduct towards client should be professional.

### VIII. GENERAL RULES

- 1 The competition simulates a law office consultation in which two participants deal with a client. The participant team conducts an interview with a dummy client and the judge evaluates the performance.
- 2 The topic of client counselling shall be provided 24 hours prior to the competition and the client will be provided on the spot.
- 3 The participants will be evaluated by a panel of judges considering the specific criteria based on listening to clients, questioning, planning and analytical skills of a lawyer.
- 4 During post-counselling and consultation, judges can ask the participants questions for further clarification.
- 5 The participants shall maintain the decorum of the court room and behave accordingly during the competition.
- 6 The decision of the judges with respect to the results of each round shall be final and binding.
- 7 The organizers may change parts of the rules and/or format of the competition, without prior intimation, but every team shall be informed about the change, if any, before the competition.
- 8 For all rounds, each team will be marked on a scale of 100 marks.
- 9 The decision of the organizers shall be final on any matter including circumstances not envisaged in the rules and regulations of the competitions.
- 10 During the counselling period, students are expected to elicit the relevant information from the client, explore with the client his or her preferred outcome, outline the nature of the problem, and suggest to the client to resolve the problem.
- 11 The participants will be evaluated considering the specific criteria based on listening to clients, questioning, planning and analytical skills of a lawyer.
- 12 Team members are entirely free to decide the work distribution, but both competitors must consult with the client as a team.

13 Participants are not expected to bring any props or office furnishings for use in the rounds. It is clarified that there shall be no weightage whatsoever in the marking criteria for the same. Provided, that this shall not be construed as a prohibition against bringing books or any other relevant materials into the room.

14 Any attempts to speak about controversial matters such as religion, race, caste, gender, foul language or anti-national rhetoric will be a ground for

- 2 All teams will receive participating certificates only during Results Ceremony.
- 3 Certificates will not be provided to the participants who are absent during the Results Ceremony.

## MODEL UNITED NATIONS

### ABOUT THE EVENT

The Model United Nations (MUN) event to be held on 5th-6th March 2025 in offline mode focuses on simulating the United Nations Human Rights Council (UNHRC), offering participants a unique opportunity to engage with critical global issues through the lens of international diplomacy and human rights advocacy.

This academic simulation faithfully recreates the procedures and dynamics of the United Nations, challenging students to step into the shoes of delegates representing UN Member States. As they navigate complex human rights issues, participants will hone essential skills including public speaking, negotiation, critical thinking, and diplomatic problem-solving.

The UNHRC simulation provides a platform for students to delve deep into the council's vital role in promoting and protecting human rights worldwide. Delegates will grapple with real-world human rights violations, propose solutions, and work collaboratively to draft resolutions that address these pressing concerns. Throughout the event, participants will gain invaluable insights into the intricacies of international relations, the UN system, and the global human rights landscape. They will learn to analyse situations from multiple perspectives, conduct thorough research, and articulate persuasive arguments while adhering to formal debate procedures.

### ELIGIBILITY

All undergraduate and postgraduate students enrolled in colleges across Delhi and the National Capital Region (NCR) are welcome to participate in the Model United Nations event. We encourage students from diverse academic backgrounds to join, fostering a rich exchange of ideas and perspectives.

### **COMPETITION GUIDELINES**

A detailed Rules of Procedure (ROP) document will be circulated to all participants at a later stage. However, here's a brief overview of the UNHRC committee procedures: The session begins with roll call, followed by setting the agenda and establishing a speakers list. Formal debate alternates with moderated and unmoderated caucuses, allowing for structured speeches and informal discussions. Delegates collaborate on working papers and draft resolutions, which can be amended before voting. Throughout the proceedings, participants can raise various points and motions, such as points of order or motions to suspend the meeting. Delegates may yield speaking time and request rights of reply. Unlike some UN bodies, the UNHRC has no veto power. These procedures aim to simulate real UN operations, fostering diplomacy and consensus-building among participants.

### **THEMES**

Model United Nations UNHRC committee will focus on the critical theme of "Armed Conflict and Human Rights of Refugees." In light of recent global conflicts such as those in Ukraine, Middle East, Gaza, Myanmar etc; this topic has become increasingly urgent. Delegates will explore the complex challenges faced by refugees in conflict zones and the responsibilities of various actors in protecting their rights. The theme encompasses the obligations of states and armed groups to safeguard civilian populations, the crucial role of humanitarian organizations like UNHCR in providing protection, and the application of international law in upholding refugee rights during armed conflicts. Participants will delve into strategies for minimizing the impact of hostilities on civilians, ensuring safe passage for refugees, and addressing the long-term implications of displacement. This theme encourages delegates to consider innovative approaches to protecting vulnerable populations and fostering international cooperation in times of crisis.

### II. Submission guidelines

For the first phase of the competition, all the entries are to submitted in a .doc format at usllslawfestofficial@gmail.com till 2nd March 2025 with the subject "SUBMISSION FOR LEGAL STARTUP & BUSINESS PLAN". The Submission should be a comprehensive business plan including the following details:

Only individual participation is allowed.

### **COMPETITION GUIDELINES**

- 1. This is an individual event.
- 2. Each Participant will be given 10+2 minutes to present their petition.
- 3. The participants are required to draft a Public Interest Litigation (PIL) petition and file it before the Hon'ble Supreme Court of India.

- 7. If a participant wishes to submit any annexure to support his/her arguments contained in the PIL (for instance Reports, Commentaries, News Clippings, Pictures, etc.) a compendium of all the relevant annexure must be prepared and should be attached along with the PIL Petition.





- 'The participants are required to bring their own costumes and props.
- Any music to be used for the performances must be shared with the organizers well before the competition starts to ensure smooth functioning.
- The time limit allotted to each participant will be 3 minutes.
- The participants will be judged on the basis of creativity, uniqueness, entertainment value, presentation and confidence.

### Round 2: Ramp Walk

- · Contestants will walk the ramp, showcasing their attire and confidence.
- The attire should be in line with the theme of the competition which is 'Culture and Heritage'.
- · The ramp walk should showcase the contestant's poise, posture and sense of style.
- The participants will be judged on the basis of body language, style, confidence and charisma.

### REGISTRATION


- Participants are required to register till 1st March 2025.
