CONCEPT NOTE

Society is the systemic ordering of social relationships based on definite patterns. It seems that the three-phenomenon occurred one by one in the evolutionary process of universe. The first inorganic and then organic, and later the super organic structures came in existence. The study of inorganic structures of universe became the domain of physical sciences which includes physics, chemistry, geology, and astronomy. The organic structures of universe are domain of life sciences such as botany, zoology and psychology. The simplest yet complex, i.e. the super organic structure of the universe is the domain of sciences known as social sciences which mainly focus on the study of society and culture. The social sciences which emerged first are basically ethnology and sociology. The later developed the various branches of social sciences are Anthropology, Economics, Political science, History, Criminology, and Law, etc. and thus these became the subjects of study in academia for the understanding of various nuances of the social order of human society.

Law has emerged as one of the strongest instruments of social control in the society by applying various rules and regulations for the orderly arrangements and interactions of human behaviors in the society.



Duguit mentions that the function of law was to promote social solidarity, and its validity grew from its competence to prevent or remedy social disorder. It is said that the law is the organization of social life in its most stable and precise form. The relationship between law as a discipline in academia and the other social sciences has gained much momentum after the emergence of national law schools in India. The legal education has witnessed a drastic change in its curricula where emphasis is being given on the basic understanding of social sciences and humanities such as Sociology, Economics, Philosophy, History, Political Science, Criminology, and English, etc. specially for the students who opt the B.A.L.L.B. (Hons.), B.Sc.LL..B. (Hons.) and such other programmes.

The National Knowledge Commission Report (2007), Government of India has categorically mentioned that the curricula and syllabi must be based in a multidisciplinary body of social science and scientific knowledge. Curriculum development should include expanding the domain of optional courses, providing deeper understanding of professional ethics, modernizing clinic courses, mainstreaming legal aid programmes and developing innovative pedagogic methods. Legal education must also be socially engaged and sensitize students on issues of social justice.



The National Education Policy, 2020, Released by the Ministry of Human Resource Development, Government of India has given much emphasis on the adoption of multidisciplinary education and research in academia. A holistic and multidisciplinary education would aim to develop all capacities of human beings -intellectual, aesthetic, social, physical, emotional, and moral in an integrated manner.

The basic objective of multidisciplinary approach is to understand and research the various aspects of human social interactions and connections such as social, cultural, economic, political, psychological, historical, criminological, and legal, etc. which ultimately make the social system more functional. Roscoe Pound in his theory of social engineering has remarked that the logic of law/philosophy of law i.e., jurisprudence is having close nit with ethics, economics, politics, criminology, and sociology, etc. which distinct enough as the core, are shade into each other. The multidisciplinary and interdisciplinary approaches are the necessities of study and research in contemporary academic life of the world.

The coordination and cooperation among the legal scholars and other social science scholars will definitely be very helpful to understand the different aspects and spheres of human behaviors with the human and environment. Law is textual arrangement. Until and unless this textual arrangement is not taking the shape at the level of society, law never succeeds to serve its purpose in the society.



Legal theorist Eugen Ehrlich says that the centre of gravity of legal development lies not in legislation, nor in juristic science, nor in judicial decision but in society itself. Thus, the integration and synthesis become the core of multidisciplinary research.

The Faculty Development Program (FDP) on Law and Social Sciences places a strong emphasis on research, recognizing it as the cornerstone of academic and professional advancement.
