The Competition is scheduled to take place from February 28 to March 2, 2025. The Competition will host 32 teams from India and overseas, selected based on the experience and accomplishments of the universities in the field of Alternative Dispute Resolution. TRAVEL & ACCOMODATION

The registration fee will cover a comfortable stay at a hotel in Jodhpur for the duration of the Competition, intra-city travel between the accommodation and the University, breakfast and lunch, along with a networking and a social event on the days of the Competition. Travel expenses to Jodhpur, including visa and related expenses, shall be borne by the participants individually.

COMPETITION FORMAT

Each team shall consist of 2 participants, representing the Client and the Counsel, with 2 teams set to negotiate with each other representing opposing parties in the Preliminary Rounds.

The General Information shall be given to the participants to assess the positions and interests of both parties and to determine the business needs of both sides.

The Confidential Information shall be provided 1 hour prior to the negotiation session, informing the teams about the side they would be representing.

The top 8 teams from the Preliminary Round shall advance to the Quarter-Final Rounds, after which teams would advance on a singleelimination/knockout basis.
