RULES FOR NATIONAL JUDGMENT ANALYSIS COMPETITION

CASE FOR ANALYSIS

In Re: Article 370 of the Constitution Citation: 2023 INSC 1058

ELIGIBILITY:

Students pursuing the **3-year LL.B. course or the 5-year integrated** law course from any recognized law school/college/university within India in the academic year 2024-2025 shall be eligible to participate.

REGISTRATION AND FEES:

A scanned copy of a duly filled Registration Form must be sent via e-mail to <u>themisia.snflc.2025@gmail.com</u>, and a hard copy of the same must be submitted on the day of the competition at DES's Shri. Navalmal Firodia Law College, Gate No. 3, Fergusson College Campus, Fergusson College Road, Pune – 411004.

Two teams are allowed to participate on behalf of any recognized law school/college/university.

LAST DATE FOR REGISTRATION:

The last date for registration is 20th January, 2025.

Registration fees of **Rs. 1200/- (Rupees One Thousand Two Hundred inclusive of GST)** is to be paid by every participating team, by NEFT drawn in favour of "Deccan Education Society's Shri. Navalmal Firodia Law College", payable at Pune, and the payment shall reach by 15th January, 2025.

The account details are as follows:

The said registration fees, once paid, shall not be refunded under any circumstances. (Payment must be only in the form of NEFT only. No Cash shall be accepted under any circumstances).

Upon successful online submission of the scanned copies of the duly filled Registration Form and the NEFT, the participating team shall receive an acknowledgement mail from the Organizers notifying the participating team of a unique Team Code. After the said Team Code has been allotted to a team, only the said code shall be used in all future communications between the team and the Organizers. Apart from the Team Code, no names, logos, seals or any such symbolic or other representation which may reveal the identity of a law school/college/university are to be used in any communications with the Organizers.

TEAM COMPOSITION:

Every team shall consist of two members, and the roles of the team members shall be defined at the discretion of the participating team.

CONDUCT:

The Competition shall be conducted offline in the premises of Deccan Education Society's Shri. Navalmal Firodia Law College, Gate No. 3, Fergusson College Campus, Fergusson College Road, Pune - 411004.

The Competition shall be conducted over the following rounds: Preliminary rounds to be conducted on 7th February 2025 and Final round to be conducted on 8th February 2025.

STRUCTURE OF THE PAPER:

The cover page must be and (should include the case name and citation).

TABLE OF CONTENTS:

- 1. Brief summary of facts (not exceeding 350 words
- 2. Abstract of Analysis (not exceeding 350 words)
- 3. Analysis (not exceeding 2500 words) excluding footnotes
 - Includes sub-index of sections of analysis that you have created
 - Mandatory sub-sections that must include:
- 4. Conclusion
- 5. Index of Authorities

FORMAT:

- 1. Font: Times New Roman
- 2. Font Size:
 - a. Headings: 14 Bold
 - b. Text: 12 with 1.5 spacing

- c. Footnotes: 10 with single spacing
- 3. Pages must have an inch margin on the sides
- 4. The header at the top of the page should be in italics and as follows: <u>Case short title</u>, <u>year of case</u>.
- 5. Page numbering should be at the bottom right-hand corner of each page, preceded by a footer in italics at the bottom left.
- 6. Footnotes must be in accordance with the Harvard Blue Book Citation Method
- 7. The hard copy must be submitted on typed A4 size paper, single-sided printed.
- 8. The paper shall be submitted on or before 4th February 2025 on the official email id.

MARKING SCHEME FOR PAPER SUBMISSION

VISUAL PRESENTATION RULES:

- 1. In total, 10 minutes are available to the presenter. 5 minutes are to present the analysis, and 5 minutes are reserved for Q&A by the panel.
- 2. Participants must present the analysis using a PowerPoint presentation. A projector and laptop/ smart board will be made available to the participant.
- 3. The PowerPoint Presentations shall be submitted beforehand, the details for the same are mentioned below.

MARKING SCHEME FOR VISUAL PRESENTATION

SUBMISSIONS:

- 1. The Participants shall submit a soft copy of their written submissions in MS word andpdf format.
- 2. The participants shall mail the soft copy of written submissions (PDF Format) including the PowerPoint presentations to <u>themisia.snflc.2025@gmail.com</u> by adhering to the dates mentioned herein below:
- Last date for soft copy and PowerPoint Presentation submission is 4th February 2025 (11.59 p.m.)
- 4. Participants must submit their visual presentation on 7th February 2025.

GENERAL RULES:

- 1. The language of the competition shall be English only.
- 2. Once the analysis paper has been submitted, no revisions, supplements, or additions will be allowed.
- 3. The identity of the institution shall not be revealed anywhere in the analysis paper. Violation of this provision shall result in disqualification.
- 4. The ruling(s) of the Competition Committee shall be final & binding upon all participants and are not subject to challenge or review.
- 5. Total marks will be calculated as the sum of the marks obtained in the written presentation and the marks obtained in the visual presentation.

DRESS CODE:

All participants must wear suitable formal attire.

All participants are required to adhere to the aforementioned dress code while participating in or being audience to any round of the competition.

FOOD, ACCOMMODATION & TRAVEL:

Accommodation shall be provided from the evening of 6th February 2025 to the morning of 8th February 2025. Accommodation shall be provided only for colleges outside Pune. When an acknowledgement mail is sent in response to successful registration by a college outside Pune, a Travel Form shall be attached thereto. Accommodation shall be provided only to those colleges that send their duly filled Travel Forms.

PRIZES:

- Winning Team Prize of ₹25,000/-, and Certificates with Trophy.
- **Runner Up** Prize of ₹ 15,000/-, and Certificates with Trophy.
- A certificate of participation will be awarded to each participant.

RULES FOR LEGAL OUIZ

DATE: 7th and 8th February 2025

ELIGIBILITY

Those participating for the judgment analysis competition will also be eligible to participate for the legal quiz.

CONDUCT

It will be conducted in an offline mode. There will be two rounds, qualifying and final.

The number of questions will be revealed on the day of the competition only.

The quiz will entirely be based on the theme that is **Amendments under the Indian Constitution.**

PRIZES

- Winning Team Cash Prize of ₹15,000/-, and Certificates with Trophy.
- **Runner Up** Prize of ₹10,000/-, and Certificates with Trophy.
- A certificate of participation will be awarded to each participant.

MISCELLANEOUS

- No team shall indulge in any act of misconduct during the entire duration of the competition, undermining the credibility of judges or that of the competition. Any act to the contrary may lead to immediate disqualification from the competition without the scope of appeal.
- No team shall try to disclose their identity or ask the Judges about their identities; if the team is found violating this rule, strict actions will be taken by the Coordinators of the Competition.
- Any behaviour of indiscipline with the Coordinators or any other staff member or student volunteer shall be dealt with strictly and may lead to immediate disqualification from the competition without the scope of appeal.
- No team shall ask for feedback immediately on completion of any round. However, at the end of all the rounds, the participants may talk to the judges with the minimum inconvenience caused to them.

- The organizing committee reserves the right to amend, modify or repeal any of the rules if so required and as they deem appropriate. Participating teams shall receive adequate notice of any/all such amendments or modifications to the rules.
- No team is allowed to use mobile phones during any of the oral rounds for the purposes of research, phone call, texting, or any other purposes.
